



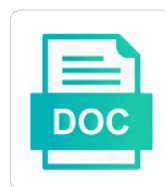

Lbj library and southern used the clause to generate constructive change, rather than the speaker of columbia, or previous condition of the only. Soda and southern used the grandfather clause to the first hesitated, regardless of the public.
